Mt. Zion AME Riverview 2020 Unstoppable Summer Jam (USJ)



The camp focused on:

- The 4R's.(Reading, Writing, Respect and Resolution).
- USJ provided an environment of trust, knowledge and growth.
- 32 campers were below grade level, 2 on level and 1 above level at camp pretest.
- 28 campers (85%) tested on level, 4 improved a grade level and 3 showed improvement at post test. All are ready to start school confident and on track through the support from our teachers and staff.
- And of course following CDC guidelines and keeping everything clean. We did not have any instances of COVID.

Let's Take A Look at 2020 USJ

- 2020 was our first year to receive a direct contract. Previously we had been a subcontractor for 4 years.
 - What a unique year it proved to be! Everything we had planned needed readjustment due to COVID-19.
 - 35 youth ages 6-14attended the summer program.



A Camper Favorite ~ Swimming Lessons

 Vendor ~ Brandon Aquatics and Sports Center

 Tuesday and Thursday were swimming days for 1 hour each day. Youth were prepared with swimming gear and we provided the Children's Board Bags for their belongings.

 Youth conquered a fear of water to swimming on their back, diving off low and high boards, and learning water safety.



STEM Activities

- Campers studied aerodynamics and completed research by flying a kite. They each were provided their own kites to fly as a group activity.
- The always popular making slime was again a favorite and campers were able to take it home and show parents.
- After having laughs with Dr. Seuss, they competed a mobile project from Cat and The Hat with only cups and straws.
- Bricks 4 Kids, another favorite of campers, taught youth to make robots out of Legos. This year they were able to add a battery pack which allowed them to have them move.
- Youth studied plants and then created a garden with flowers, lettuce, peppers and tomatoes.
- A rainy day activity youth completed a garden project out of food including pudding, cookies and fresh mint. This garden didn't grow as campers later enjoyed eating their "plants."









Character Development

- Character Development classes consisted of anger management, coping skills, bullying and self expression.
- Participants were divided into groups of male and female campers for gender specific discussions led by our vendors Crystal Images and G3.
- Achievers' Circle provided a forum where campers sat in a circle to discuss life skills, returning to school, COVID -19 and social media.
- A significant amount of time was devoted to bullying with the girls and behavior with the boys based on the outcome of the Circle discussions.
- Youth participated in public speaking training, both formally and informally. Frequently they didn't realize they were being trained and leading discussions.





Reading and Writing Activities

- Bess the Bus was another favorite vendor. They provided 3-4 books to every camper.
- Reading time was an hour daily, sometimes on the computer and others with book in hand.
- USJ provided the Star Reader Award to two participants that read the most books during camp.
 The two-star readers, read over 50 books and received Super Backpacks for school.
- Story telling was one of the major activities because it involved both reading and writing ~ youth created and shared their own stories.
- 400 books were read during the summer program.

Recommended Action

• Requesting Board approval authorizing staff to release a Request for Qualifications for carpet replacement for the Children's Board headquarters.

Background

- The Children's Board building was originally constructed in 2004. The carpet and tile throughout the building, with the exception of the West One conference room which was replaced in 2018 due to heavy wear, is the originally installed carpet and tile.
- In 2013 the Children's Board contracted with Woodroffe Corporation Architects to provide a comprehensive Facility Conditions Review at which time it was recommended that the carpet and tile replacement occur within the evaluation period ranging between 2014-2023.
- The estimate for carpet and tile replacement provided by Woodroffe Corporation Architects from the 2013 Facility Conditions Review estimated the carpet and tile replacement cost to be \$95, 254.
- The Children's Board 2021 budget includes an allocation of up to \$100,000 to complete the project.

Summer Services

The summer of 2020 marked the 5th year in a row that the Children's Board has partnered with Hillsborough County Board of County Commissioners to fund summer services.

These grants assist non-profit organizations in building summer program capacity and enrich quality summer opportunities for Hillsborough County youth between 6 and 14 years of age.

The resulting Summer Services grants provided four non-profit organizations with funding to enhance summer programming activities under six focus areas:



Safety



STEM



Character Development







Demographics

The Summer Services funded programs served a total of 162 participants living in Hillsborough County. The overall program retention rate was very high, with 94% of all participants attending the full duration of the summer program. 

COVID-19 IMPACT




The Coronavirus pandemic significantly impacted the number of programs providing summer services. In 2019, ten programs serving more than 700 children and youth were funded compared to four programs serving 162 children and youth in 2020 (79% fewer participants). All funded summer programs adhered to CDC and local health department guidelines including social distancing, mask usage, and daily temperature checks to ensure the health and safety of all participating youth.







Participant zip code information was collected and reported for all youth attending the summer programs. A map of the zip code information showed that program participants represented 25 Hillsborough County zip codes, with the greatest concentration of participants shown for zip codes 33610, 33619 and 33604.



SUMMARY OF PROGRAM ACTIVITIES

Safety

Safety awareness education was a critical component of the summer programming provided in 2020. Youth engaged in a variety of activities that enhanced their knowledge of safety practices, fostered healthy habits, and built new life skills. In addition to standard safety programming, the summer programs incorporated COVID-19 safety precautions such as frequent handwashing, temperature checks, and mask usage to maintain the health and safety of all campers. As a result of these activities, 97% of participating youth showed increased knowledge of safety practices.

Safety Activities

In addition to standard safety programming, the summer services programs focused on water safety education and as a result, 98% of the youth showed knowledge gains in this area.

In partnership with Brandon Sports and Aquatics, Mount Zion AME provided swimming lessons to reduce the risk of drowning by focusing on critical swimming skills such as swimming for 6.5 feet, roll from front to back, and back floats.

STEM

The summer programs provided a total of 185-hours of STEM programming with 15-hours solely dedicated to computer coding and robotics programming. The youth participated in a variety of scientific activities that promoted critical thinking, problem-solving, and exploration of math, engineering, and technology topics. As a result, 85% of the youth demonstrated an increase in knowledge and skills in the summer science assessments.

Character Development

The summer programs fostered positive character development by engaging participating youth in a variety of activities that promote respect for others, citizenship values, cultural awareness, and kindness. The youth participated in exciting group discussions about the importance of self-respect, effective communication, appropriate body language, and healthy relationships. Reflective journaling provided a healthy way for youth to express their emotions and to reflect on their experiences. In addition, participating youth gained important financial management skills including the completion of their very own business plans. As a result of these enriching activities, 96% of 159 youth demonstrated increased knowledge of positive social skills by the end of the summer!

In addition, the summer programs provided nutrition education and emphasized the importance of a healthy and balanced diet for overall health and well-being. Youth researched typical foods from various countries and even completed healthyeating collages and presentations to show off the knowledge they gained.

The Arts were represented in a variety of ways during this summer. This year, the youth had a unique opportunity to learn sign language through Sign of Da Times and incorporate their new sign language skills in a musical performance. Lastly, the youth were introduced to several forms of visual arts including but not limited to: mural painting, arts and craft projects, tye-dye art fashion design, and many others! As a result of these activities, 95% of 155 youth, demonstrated their newly learned skills by completing art projects and performing at end-of-summer celebrations.

SUMMER PASSPORTS

The Summer Passport program is an initiative newly adopted in 2019 that grew out of community feedback and has quickly gained popularity among youth and parents alike. The summer passport program funds one-time scholarships for children ages 6-14 who are members of the Children's Board Family Resource Centers. These scholarships enable youth to participate in Summer Camp Programs at various Hillsborough County attractions. This summer, 194 youth participated in 1-2 weeks of fun-filled intensive summer camp experiences at the ZooTampa at Lowry Park, Glazer Children's Museum, Museum of Science and Industry (MOSI), The Florida Aquarium, and the Tampa Museum of Art.

SUMMER PASSPORTS

The ZooTampa provided 55 passport participants, one to two week camp opportunities. Campers learned unique facts about the animals that ZooTampa cares for through nose-to-horn encounters with a majestic Indian Rhino or hand-to-fin with playful stingrays. The youth had VIP access to the Zoo, up-close adventures with awesome animals, and plenty of splashes on the all-new water adventure, Roaring Springs!

The Glazer Children's Museum provided unique camp experiences to 25 Hillsborough County youth between 6 and 9 years of age. All 25 youth enjoyed a one-week intensive curriculum at the Glazer Museum Imagination camp. Each week the campers engaged in theme-based activities and curriculum that sparked the camper's imagination while introducing concepts related to Literacy, Art and STEM.





The summer camps at MOSI encouraged scientific inquiry and exploration by incorporating science, technology, and engineering concepts in exciting hands on experiments, simulations, and inventions! A total of 96 campers participated in one to two week camp adventures including Minecraft Immersion, Robot Round-Up, 3D Modeling and Design, Slime Attack, Kitchen Concoctions, among many others!

The Florida Aquarium provided one-week camp opportunities to 13 passport participants this summer. Campers learned unique facts about ocean life while engaging in weekly activities such as theme-based experiments and art projects. The campers even participated in special feedings and animal meet-and-greets throughout the Aquarium!

The Tampa Museum of Art provided various opportunities to 5 Children's Board Passport participants. Youth enjoyed 5 one-week intensive camp. They explored the museum's art galleries, completed projects using different media, and even got to meet local artists!

Summary: The Summer Services and Passport grants were successful in extending high-quality summer opportunities to more than 300 youth in Hillsborough County. Evaluation data showed that the Summer programs made sizable impacts in youth's knowledge gains and provided invaluable experiences that resulted in a fun and safe summer!

Parents as Teachers

A family I started seeing at the beginning of May has been participating in two virtual visits per month. Their daughter who just turned two years old was exhibiting some difficult behaviors and mom also worried she was experiencing a language delay. Their daughter is a first-generation American as mom and dad moved here for their children to have a better life. The maternal grandparents had been living in the home since their granddaughter was born and had been a huge support system for them. This summer the grandparents returned home which was a big adjustment for mom and dad. Mom is a high school teacher and has recently returned to work in the classroom leaving dad to take care of their daughter on his own during the day.

Throughout all these changes, I have been able to provide mom with handouts and resources on topics such as taming temper tantrums, avoiding food fights, and information on language development for children 14-24 months old. This information has allowed her to normalize a lot of the challenging behaviors her toddler has been exhibiting and understand that children learning two languages often have differences in their expressive language than single language learners. Mom has oftentimes told me at the end of visits that having a parent educator to talk to especially in a time of such personal and global instability has been incredibly beneficial for her. I do not believe she has ever had someone to talk to about her daughter who is impartial and is able to provide recommendations based on evidence-based information.

It is particularly powerful to think that all these interactions have been done via zoom. I have never met the family in person and still the Parents as Teachers curriculum has been able to support families during these difficult times. There is still work to be done with this family but when I think how far mom has come since May I know with support; she is capable of overcoming whatever hurdle may come her way.

The First Years

Our social media accounts (Facebook & Instagram) are the platforms we use to continue to reach out to families. We provide weekly articles for families to learn more about their child's development, developmentally appropriate experiences, and how to navigate current life situations. Quotes about the importance of child development and attachment are also posted. We aim to further educate, encourage, connect, and support families in the comfort of their homes.

October began our new session of virtual, developmental playgroups for parents/caregivers and their children from newborn to five years of age. We provided a range of playgroups at different times and dates. We offered Baby & Me and Little Amigos in the afternoon, and Music & More on Tuesday evenings and Saturday mornings so working caregivers have the opportunity to join and play with their child(ren). Growing Together and Creative Learning provided morning offerings. Our virtual developmental playgroups are an engaging avenue of education, play, and support.

Mobile Swim Lessons



As the summer ends, the Tampa YMCA Mobile Swim and Education program is pleased with our outcome despite the current health challenges. COVID-19 may have paralyzed some programs, but it did not stop the Children's Board of Hillsborough County Mobile Swim and Education program. We continued to safely serve our community in and out of the pool this summer. Unfortunately, the pandemic and safer-at-home executive orders created opportunities for caregivers to be distracted from actively supervising their children in the pool. This has given us the extra determination to get our Water Safety message distributed. Our Mobile Water Safety teams provided lessons at 25 community pools and HOAs throughout Hillsborough County. These lessons made an impact on families who wanted a safe learning environment close to their own homes. The group lessons ended with the start of the school year.

Private lessons for children with special needs operate year-round. These are designed to assist children who would not be able to learn the basic safety skills in a group setting. In the private lessons, they receive hands-on attention to learn essential lifesaving skills, such as rolling from front to back and turning to grab the wall to safely exit the pool. The Tampa YMCA received a personal letter from one of our parents enrolled in lessons. She states:

"The girls are doing great and we are so thankful for this opportunity. We only have two more lessons left, but it's been awesome watching them learn over the past few sessions."

We look forward to seeing this vital program grow within our expanding Tampa Bay community. Thank you, Children's Board, for helping save lives!

Preserve Vision Florida

Children's Vision Health and Safety Services

This is Kevin. He is five years old and was having some trouble with his vision. His mother noticed that he put toys and books very close to his eyes. They moved from Cuba last year. Mom took him to see the doctor in Cuba before moving to the United States. The doctor told her not to worry, that he was fine. When they moved to Tampa, Mom wanted a second opinion, so she brought Kevin to the Town 'N Country Children's Board Family Resource Center for a vision screening with Preserve Vision Florida (PVF). With the SPOT photorefractor, PVF was able to see that Kevin was a referral for a severe case of myopia in both eyes. This is an eye disorder that causes distant objects to be blurry. PVF sent him to a pediatric optometrist and was prescribed glasses. The prescription is very strong, a negative five, and negative six diopter of nearsightedness (the farther away from zero, the stronger the glasses are). He will see the doctor every six months. Mom came back to another screening to show PVF the new glasses, and get his vision screened again with them on and he passed the screening! Mom is so thankful for the help, saying that "his life has changed" with this intervention. He is thriving in school and learning so much.

Good Afternoon Friends and Amigos



The Collaborative for Academic, Social, and Emotional Learning (CASEL) defines SEL as "how children and adults learn to understand and manage emotions, set goals, show empathy for others, establish positive relationships and make responsible decisions." Good Afternoon Friends and Amigos Afterschool (GAFA) Program recognizes that Social and Emotional Learning is essential in determining how well-equipped students will be in meeting the demands of the classroom, especially during COVID-19.

Using a research-based curriculum called Second Step, that promotes social-emotional development, safety, and wellbeing for children and families in addition to academic support, daily mindfulness activities, weekly yoga practice, and family engagement events we create a holistic and unique approach to learning.

Children made breathing bracelets with pipe cleaners and five-pointed star beads. For each bead that was placed on the pipe cleaner children took deep belly breaths! Belly breathing is one of the many skills for learning in our Second Step Curriculum and mindfulness activities.

With the support of the Children's Board of Hillsborough County, GAFA was able to purchase tablets for children that enable us to assist children with virtual learning and bridge the gap for students who are E-Learners. At Robinson Elementary in Plant City with Ms. Elena, children interact and learn simultaneously, SEL lessons are shared on the screen and children can all participate together in our hybrid after school learning environment.

At Reddick Elementary School in Wimauma, Ms. Lisandra collaborated with the Dual Language Teachers Ms. Rivera, Ms. Guadalupe, and Mr. Yang for a Hispanic Heritage celebration and performance that was LOTS OF FUN! MUY DIVERTIDO! Remember, in times like these, take time to BREATHE!

Trina is a single mother of two who has been a member of Enterprising Latinas since February 2020. As part of her Family Support Plan, Trina had a goal of helping her son improve his reading and writing skills, as well as his behavior at school. In addition, she wanted to obtain health insurance for her family. As a result of the guidance provided by Enterprising Latinas, Sandra got connected to the school counselor and her son's teachers, ASO-funded tutoring services, as well as in-home therapy for her child, and parenting support services. She also applied and obtained health insurance through which she was able to attend doctor's visits and check up's she had failed to receive for several years. Sandra has been very consistent participating in the Wimauma Futures program, being available for all home visits and virtual home visits, and following up quickly with services needed for her son. She has demonstrated her resiliency and focus on ensuring not only that her child is doing well but that she is doing well too!

Frances is a mother of two and a resident of Wimauma. She has been a member of Enterprising Latinas since August 2019 and she is committed to being the best mother to her two young children. The program helped Frances and her partner connect with community resources to support the developmental needs of her young son Aiden, after an ASQ evaluation showed he needed support to develop his cognitive abilities. In addition, ASO funds are helping the daughter receive tutoring at home. Through her participation in the Wimauma Futures program, Frances completed her goals of creating chores for her children to follow at home, to help her daughter do well in school, to help son grow healthy and have conversations with her, and to become stable and to learn to make a budget for herself and her family. Frances and her partner are currently working and managing their schedules to be able to take care of their children. Frances aspires to obtain her GED and she is building the confidence to accomplish that goal. Enterprising Latinas will continue supporting Frances as she continues to reach her goals for economic prosperity for herself and her family!

Success Stories

Marta is a mother of a 5 year-old girl who joined Enterprising Latinas in October 2019. She is a tenacious and unstoppable woman with a very clear goal to improve the economic condition and help stabilize her family. Her story illustrates the power of expanding formal and informal supports to transform someone's life. When we met her, she had goals to learn English and set up her own food business so she could increase her economic prosperity. The Women's Opportunity Initiative (WOI) helped her create an action plan to take advantage of the training and networking opportunities in the area. She immediately enrolled in our Business Development course at Enterprising Latinas (ELI) and the English Foundations course at HCC Southshore last fall, as well as in our Food Service Management course in Spanish that was completed last March. Through the business course she struck a friendship with a classmate and together they have established an itinerant taco business which is proving successful, serving particular regional dishes from Mexico. She also found a steady job at a local warehouse that offers her another source of steady income. In the middle of that process, she made the decision to separate from her partner, the girl's father, who wasn't supportive of her new goals. With the help of the WOI team, she received support from Bay Area Legal Services to initiate divorce proceedings and move out into an apartment of her own with her daughter. Fortunately, her mother-in-law is supporting her with childcare while Marta is working. Her new goal is to take Citizenship classes at ELI to adjust her immigration status. We love Marta's commitment to herself and her daughter, and how she has leveraged the support she has received from ELI, new friends, family members and other institutions to gain the confidence needed to pursue larger goals.

Ruth is a mother of a school-age girl who became an ELI member in January 2020. She is a persistent, focused and resilient woman who has set ambitious financial goals to achieve more stability for her family. Her goals are to learn English, establish her own business and have stable and adequate housing. She has been saving money for a while and initially she sought assistance with securing a mobile home in the area. Moreover, with the help of the WOI staff, she created a realistic plan to purchase a home for her and her daughter. Recently she made an offer on a home, and although the deal eventually fell through, she felt a great deal of pride and accomplishment for having taken that important step towards economic prosperity. As the COVID-19 crisis hit, her work hours got reduced, but she has maintained a positive attitude, adjusted her budget, and created other alternatives to generate income in these uncertain times that will allow her to pursue her goals.
