Parris informed the Committee of the following details related to Countywide evictions:</li> <li>Bay Area Legals Services (BALS) will be conducting virtual training with ASO case managers on December 2, 2020 to educate them on the eviction process and make appropriate referrals;</li> <li>Superintendent Davis was advised of the upcoming training as his social workers might find it helpful.</li> </ul>
