Recommended Actions

Recommend that the Board approves the extension of the Executive Director's contract through September 30, 2023.

Background

- The Executive Director has a rolling three year contract that is traditionally renewed each year by the Board, based on a successful Performance Appraisal Process.
- The Children's Board Attorney oversees the Executive Director Performance Appraisal Process.
- On August 22, 2022, the Executive Director completed a Self-Evaluation for fiscal year 2021-2022.
- The Executive Director's Self-Evaluation was provided to each member of the Board along with a blank Performance Appraisal Evaluation Form.
- Board members returned their individual Performance Appraisal Evaluation Forms to Jan Houser, who compiled the results of the Performance Appraisal Process.
- The results were distributed to the Board in advance of the Board Meeting.
- The recommendation to extend the Executive Director's contract to September 30, 2023 is based on the satisfactory performance of the Executive Director in FY 2021-2022 and the recommendation of the Board Attorney after polling members of the Executive Committee.





Approval of Release for 2023 Summer Services Leading Grants

Initiator: Maria Negrón, Director of Programs

Action: Approval of release for 2023 Summer Services Leading Grants

Date: Regular Board Meeting, Thursday, October 27, 2022

Recommended Actions

Recommend release in January 2023 of a Request for Proposals for time-limited 2023 Summer Services Leading Grants with a total allocation up to \$500,000 in collaboration with Board of County Commissioners to increase youth access to high quality summer programming.

Background

- The Children's Board has released summer services grants since 2015.
- The 2022 Summer Services Report was included in the October 2022 Board Book.
- The Board of County Commissioners have renewed their collaboration with the Children's Board and will contribute \$250,000. The Children's Board will serve as the managing entity for all funding and grants awarded.
- The intent is to award multiple two-year Leading Grants to existing Hillsborough County summer programs. Upon successful contract compliance, programs will receive funding in FY 2024 without having to re-apply.





Approval of Release for ONEhillsborough Enhanced After-school Programs

Initiator: Genet Stewart, Director of Strategic Initiatives

Action: Approval of Release for Enhanced After-school Programs

Date: Regular Board Meeting, Thursday, October 27, 2022

Recommended Actions

Recommend release in October 2022 of an Intent to Negotiate with total allocation up to \$425,000 for enhanced programming in select after-school and summer programs within the ONEhillsborough zip codes: 33603, 33610, and 33619.

Background

- ONEhillsborough is a community-driven initiative structured around the Social Determinants of Health (SDOH). It is designed to implement tailored, holistic, and meaningful solutions to address long-term systemic issues and disparities that predominantly Black and Brown communities face within our county.
- The overarching goals are to ensure children reside in economically stable
 households, engaging learning environments, access to preventative healthcare and
 healthy living, safe neighborhoods with health amenities, and easy access to
 supportive resources.
- Hillsborough County Public Schools Out-of-School Time (HOST), Hillsborough County Parks & Recreation and City of Tampa Parks & Recreation identified afterschool and summer school sites within the ONEhillsborough zip codes that would benefit from enhanced programming.
- The enhancements to be provided are as follows:
 - o STEM, Fitness/Health and Music at Grant Park, Jackson Heights, and Wellswood City of Tampa Parks & Recreation programs.
 - o STEM, Fitness/Health and Music at Emmanuel P. Johnson and Kenly County Parks & Recreation programs.
 - o STEM, Character Development, and Fitness/Health at the HOST afterschool programs at Mendenhall Elementary, Robles Elementary, Broward Elementary, Edison Elementary and Palm River Elementary Schools.




DEMOGRAPHICS


Summer Services funded programs served a total of 511 youth residing in Hillsborough County. More than half of the enrolled students this summer were in the 10-13 year age bracket, with a median participant age of 11 years. Program engagement was lower than rates reported for previous years, with 72% of all participating youth remaining engaged in the program for its duration.





SAFETY

Safety knowledge is paramount for having a fun and healthy summer. This year's summer services programs provided important safety activities and lessons to enhance youth's knowledge of water safety, life-saving measures, and firearms safety, among other essential topics.

This year's safety programming included youth receiving a combination of both water safety education and swimming lessons. As a result of these activities, 93% of participating youth demonstrated increases in their knowledge of safety practices.



After-School Literacy Initiative Makes A Difference In Reading Achievement

These days our children are fighting for their academic lives as the education gap between Black children and white children remains the same or has widen.

According to the National Center for Education Statistics, Black students also scored lower on reading tests at every grade level studied between grades 1 and 12.

The Parents & Children Advance Together Literacy Ministries (PCAT) is working hard to bridge the gap by offering an after-school reading program. PCAT was founded in 2003 by Christene Worley. The program has been provided services in Ruskin and is back at Sulphur Springs K-8 this school year.

The current Executive Director, Weclaige "GiGi" Moise, emphasizes that the PCAT mission is a literacy initiative which serves students who are reading below grade level and are at risk of school fail-

"Reading is fundamental to all schoolwork and suc-

cess in school. It affects math, history, and social studies. Everything is based on reading and reading comprehension. For children to be successful, they must be able to read and understand what they are reading."

Moise was born and raised in Miami and graduated from Florida Atlantic University. She has been on staff with PCAT since 2017, but initially worked with PCAT as a volunteer, reading to kindergarten students at Sulphur Springs.

Her deep love of reading serves as the background for her devotion to ensure children in the community have the same opportunity to achieve their dreams through reading and comprehension skills.

"The success of our program stems from our ability to provide individualized reading plans for our students along with one-onone instruction," states Moise.

Moise gives much credit to Marc Gaillard, principal at Sulphur Springs K-8 Community School, and Emerson Morris an educator and founder of Father's University. Father's University has provided services and resources for fathers of children in the program.

PCAT is provided at no cost to students.

The Sulphur Springs initiative is funded by The Children's Board of Hillsborough County and a generous gift from the Kay Andrews Education Foundation, while the Ruskin initiative is funded by The Children's Board of Hillsborough County, Community Foundation of Tampa Bay and Suncoast Credit Union as well as private donations received from the

supporters of PCAT.

Students are tutored by certified teachers, staff and volunteers who receive comprehensive training from our Education Director.

"I was born in New York, but my family is Hispanic, and Spanish was the primary language spoken at home."

The Big Sister Carmela does not only show little Alexander the importance of learning English, so he can succeed in school but also the importance of being bilingual, which is an asset for his future education and career. Carmela also helps Alexander with math because it is a difficult subject for him. The Big Sister finds ways to make math fun so that Little Alexander can grasp the concepts.

Carmela goes above and beyond to help Alexander succeed by giving him positive encouragement, guiding him with his goals, and celebrating his accomplishments. They are a great pair!

REACHUP, Inc.

Giving Resources and Opportunities with Trust and Hope (GROWTH) with Doulas and Dads



In recognition of 10+2 years of hosting the Affirming Fatherhood Conference (AFC), REACHUP, Inc. selected "Continuing the Legacy of Affirming Fatherhood" as the 2022 theme. Keynote speakers for this hybrid Conference held September 15th-16th included Kevin "KB" Burgess, 2021 Dove Award Winner, Rap/Hip-Hop Album of the Year, 2022 Nominee for Song of the Year, and Dr. Kevin B. Sneed, Senior Associate Vice President, University of South Florida (USF) Health; Professor and Founding Dean, USF Health Taneja College of Pharmacy.

KB concentrated on the father's role in the healthy development of boys at high risk for suicide, alcohol and drug abuse, violence, and loneliness. A follow-up panel delved more deeply into the issues. Dr. Sneed centered his presentation on the pandemic realities and the structural and personal commitment needed to prevent and manage

chronic disease in combating disparities in severe disease and death.

Additional plenary sessions included a fatherhood study conducted in Dakar, Senegal, West Africa, and a historical overview of REACHUP's impact on fatherhood programs, locally, statewide, and nationally as well as on fashion and style for men and women. The Conference was rounded out by breakout sessions on men's mental health, fathers and

finances, toxic forms of masculinities, adverse childhood experiences, and addiction and recovery.

Other highlights of the Conference included the induction of three fathers – Geoff Blair, Clarence Atkins, and Rev. Miguel Maysonet – into the Affirming Fatherhood Conference Hall of Fame. A presentation of the inaugural Legacy Awards to four community members, including the Children's Board's own board member, Edwin "Ed" Narain, Evangeline Best, Dr. Ronee Wilson, and Dr. Adewale Troutman (posthumously). Lastly, a \$50,000 check was presented to REACHUP, Inc. from Simply Healthcare Plans, Inc., to support a partnership in enhancing father engagement in Tampa and throughout Hillsborough County, FL. The AFC is sponsored in part by the Children's Board.
